The name of the candidate and the course (MBBS/ BDS) should be written on the reverse of the Demand Draft. The template with requisite details available for download should be printed and pasted on the cover. SC/SCA and ST candidates who are Natives of Tamil Nadu and applying for Government quota are exempted from payment of the cost of the Application Form.

The other conditions for admission into MBBS / BDS Course will be applicable as in the case of the general category.</p>	<p>40.
