1	Two persons who have or have had mental illness -clause (l)
2	Two persons representing care givers of persons with mental illness or organisations representing care-givers –clause (m)
3	Two persons representing non-governmental organizations which provide services to persons with mental illness-clause (n)

The members referred to above will be nominated by the Government.

Eligibility Condition

- (a) In respect of individuals he/she shall be an Indian national (b) age shall be not exceeding sixty-seven years; (c) shall furnish copies of documents eligible to be nominated under clause (l) and (m).
- (b) In respect of persons representing non-Governmental organisations, the organisation should have 10 years of experience in the field of mental health and should have obtained licence with the licensing authority and shall provide copies of documents to that effect.
- (c) Term of office and allowances: The member nominated shall hold office for a term of three years at a time from the date of his nomination.
- (d) Members attending the meeting of the Authority are entitled to sitting allowance, travelling allowance, daily allowance and such other allowances as are applicable to non-official members of the Commissions and Committees of the State Government attending the meetings of such Commission or Committee.
